Your failure to vacate the property may result in the Court issuing a summary order for your removal or an order providing for your nonadmittance, directing the sheriff or constable of the county to remove you within twenty-four (24) hours after receipt of the order from the court.

YOU ARE HEREBY ADVISED OF YOUR RIGHTS to (1) surrender the real property to the Owner of the real property or Owner's authorized representative; and/or (2) request that the court stay the execution of a summary order for removal, stating the reasons why a stay is warranted; or (3) contest this Notice by filing an affidavit, no later than the fourth full judicial day¹ following the Date of Service of this Notice, with the Justice Court for the Township of (insert name of township where property is located) \_\_\_\_\_\_\_\_, stating the reasons why you are not guilty of a forcible entry or forcible detainer, and by serving the affidavit by mail upon the issuer of this Notice. Owner or Owner's authorized representative shall provide safe storage of any of your personal property remaining on the property for 21 days after your compliance with this Notice or after the execution of the order for removal, whichever comes first. You must pay Owner or Owner's representative for the reasonable and actual costs of inventory, moving and storage of the personal property before the personal property will be released to you. If you dispute these costs, you can file a motion with the court within 14 days after the surrender of the property or after the execution of the order for removal. The Neighborhood Justice Center is a free service in Clark County that may be able to help you resolve disputes regarding the time, place, and manner of the turnover of personal property.
