7 WHEREAS, JCRLV 6.5(b)(5) empowers the Chief Judge to supervise the administrative
8 business of the Court; and

10 WHEREAS, Clark County Management has asked the Court to review and revise
11 processes in an effort to alleviate the inmate population and average length of stay at the Clark
12 County Detention Center; and

14 WHEREAS, the Chief Judge consulted with various justice partners, including the Las
15 Vegas Metropolitan Police Department, the Clark County District Attorney's Office, the Clark
16 County Public Defender's Office, and Nevada Attorneys for Criminal Justice in reviewing,
17 revising, and implementing new procedures; therefore,

21 IT IS HEREBY ORDERED that a defendant who is arrested on one or more
22 misdemeanor charges, and no gross-misdemeanor or felony charges, shall be released on that
23 person's own recognizance 12 hours after arrest, except as otherwise provided in NRS 178.484,
24 if all of the following conditions are satisfied:

- (1) The defendant is not eligible for a CCDC administrative release pursuant to NRS 211.240;
- (2) The defendant is not eligible for a PreTrial-Services release pursuant to existing guidelines;
- (3) The defendant has not posted bail within 12 hours of arrest; and
- (4) The defendant is **not** arrested for any of the following offenses:
 - (a) Loitering for purposes of prostitution;
 - (b) Engaging in prostitution or soliciting for prostitution;
 - (c) Any crime designated on the Temporary Custody Record as "PROSTITUTION-RELATED" or "VICE-RELATED";
 - (d) Violation of an Order-Out Corridor Order pursuant to CCC 12.05.010-12.05.030;
 - (e) Battery/domestic violence;
 - (f) DUI with prior DUI arrest(s) or conviction(s); or
 - (g) Violation of a Protection Order.

IT IS FURTHER ORDERED that this Administrative Order shall become effective immediately.
