10 **WHEREAS**, the Chief Judge of the Las Vegas Justice Court currently has a specific  
11 calendar for "Q-Cases"<sup>1</sup>; and

12  
13 **WHEREAS**, the Court has determined that specialized procedures are needed for setting  
14 these cases for hearing and for recalling outstanding warrants; therefore,

15  
16 **IT IS HEREBY ORDERED** that when a Defendant files a "Motion to Place on  
17 Calendar" in a Q-Case for violations involving Clark County Animal Control, the Las Vegas  
18 Justice Court Criminal Division shall administratively recall any outstanding bench warrants on  
19 that particular case and then schedule the case to be heard by the Chief Judge on the "Q-Case"  
20 calendar; and

22 **IT IS FURTHER ORDERED** that if a Defendant is arrested on a "Q-Case" involving  
23 Clark County Animal Control, and if the Defendant is not in custody on any other criminal cases,  
24 the PreTrial Services Division shall release the Defendant on his or her own recognizance and  
25 then schedule the case to be heard by the Chief Judge on the "Q-Case" calendar.



**IT IS FURTHER ORDERED** that this Administrative Order shall supersede and replace Administrative Order #14-01 which is no longer in effect.

<sup>2</sup> The other case types include, but are not limited to, the following:

- (1) Violations involving the Nevada State Contractor's Board;
- (2) Violations involving code-enforcement complaints relating to the Building Code and Zoning Code for Clark County; and
- (3) Violations involving massage businesses and massage establishments under the Clark County Code.

These particular case types are randomly assigned to the department of origin upon the filing of the criminal complaint.
