



## Las Vegas Township Community Court

---

Community court uses collaborative problem-solving to respond to community concerns regarding public safety by addressing certain lower level offenses with a more comprehensive approach than a traditional court.

The community court's collaborative model helps participants with complex social needs by providing increased supervision and connection to social services.

The Las Vegas Township's Community Court will address misdemeanor offenses, and participants of community court will engage in an assessment to identify their various needs and risk of reoffending.

To ensure services are quickly and easily accessible to participants, the community court provides an onsite location and warm handoff to service providers. Individuals do not need a citation to access the help center. The court seeks to have a wide range of service options available to meet community members' needs.

In order to serve the best interest of the citizens of Las Vegas, Las Vegas Justice Court deems it necessary to conduct criminal records checks. Therefore, the following request for information must be completed and returned for you to be approved for a volunteer assignment. Your signature on this form authorizes Las Vegas Justice Court to obtain information from any law enforcement agency, court, and/or record source and to investigate any matter deemed relevant to the evaluation of your suitability for your volunteer assignment with Las Vegas Justice Court.

I voluntarily release Las Vegas Justice Court and Clark County from any claims, liability or damages related to the background check it may conduct as a result of my application for employment. I further voluntarily release all parties from liability for complying with this authorization. I will allow a Photostat facsimile of this authorization and release to be considered as though it were an original. Any falsification, misrepresentation or omission of requested information will result in denial of, or immediate termination of, your volunteer assignment, regardless of when and how it was discovered.

I have carefully read and understand this authorization and release and have voluntarily agreed to its terms to assist the Las Vegas Justice Court and Clark County in meeting the business necessity of appointing honest, trustworthy, reliable, capable and nonviolent volunteers. I further understand that

all information and documents acquired by Las Vegas Justice Court and/or Clark County will be maintained as confidential by Las Vegas Justice Court and that Las Vegas Justice Court will not release such information to me, except as required under the Fair Credit Reporting Act or other application laws. Las Vegas Justice Court has provided me with a summary of my rights under the FCRA.

The background check Las Vegas Justice Court is conducting for Community Court volunteer applicants is limited to use of consumer reports of information about the applicant's character, general reputation, and personal characteristics, and includes any records of criminal conduct, but does not include a credit check or check for credit worthiness.
