WHEREAS NRS 178.508(1)(c) requires that before declaring a forfeiture of bail based on a defendant's failure to appear in court, the court shall direct that each surety and the local agent of each surety, or the depositor if the depositor is not the defendant, be given notice that the defendant has failed to appear, by certified mail within 20 days after the date on which the defendant failed to appear; and

WHEREAS, as the result of a clerical error in the cases identified in the attached Exhibit A, the court did not direct that the required notice pursuant to NRS 178.508(1)(c) be given;

IT IS HEREBY ORDERED that each surety in the cases identified in the attached Exhibit A is exonerated and any bail released; and

IT IS FURTHER ORDERED that any warrant for the arrest of the defendant based on the defendant's failure to appear issued in the cases identified in the attached Exhibit A remains outstanding.
