8 WHEREAS, the Nevada Supreme Court's "Minimum Records Retention Schedules"
9 provide that "unserved arrest warrants" may be purged after 5 years; and

10 WHEREAS, the civil cases listed in Exhibit "A" have outstanding arrest warrants which
11 are subject to this standard; and


12 WHEREAS, the Court has determined that the outstanding arrest warrants in those cases
13 should be quashed, and the related cases should be closed, due to the passage of time so that
14 parties will not be subject to arrest based upon warrants that have become stale; therefore,

15 IT IS HEREBY ORDERED that the outstanding arrest warrants for the civil cases listed
16 in Exhibit "A" shall be quashed; and

17 IT IS FURTHER ORDERED that the civil cases listed in Exhibit "A" shall be closed.

18 IT IS FURTHER ORDERED that this Administrative Order shall become effective
19 immediately.
