7 WHEREAS, in the case of Blackjack Bonding v. City of Las Vegas Municipal Court,
8 116 Nev. 1213 (2000), the Nevada Supreme Court declared that courts have the inherent power
9 to charge and collect reasonable fees in addition to fees that are enumerated by statute; therefore,
10

11 IT IS HEREBY ORDERED that the following fees shall be charged by the Las Vegas
12 Justice Court as they are critical to maintain operations and provide access to justice:

13 **Section 1 – General – Fees Applicable in all Court Divisions**

- 14 (1) For postage and mailing (when the requester of records does not provide a self-
15 addressed, stamped envelope)--**\$2.00;**
- 16 (2) For each point-of-sale transaction--**\$5.50;**¹
- 17 (3) For the *non-expedited* retrieval of a file from off-site storage for copies, research, or
18 any other reason--**\$10.00;**
- 19 (4) For a copy of a JAVS recording of a court proceeding--**\$25.00;**
- 20 (5) For registering with the Court for community service in lieu of fines, fees, or civil
21 penalties--**\$25.00;**
- 22 (6) For issuing a check returned for insufficient funds (“NSF Fee”)--**\$35.00;**
- 23 (7) For *rush or same-day* file retrieval from off-site storage--**\$35.00;**
- 24 (8) For collecting, posting, and acting upon cash bail posted for the release of a person
25 from custody at the Clark County Detention Center--**\$40 per transaction;**
- 26 (9) For attorney access to the Odyssey Case-Management System--**\$150.00 annually.**

28 ¹ Of this amount, \$5.00 is paid to the vendor, and \$0.50 is retained by the Court.

1 **Section 2 – Civil Actions, Civil Traffic Infractions, Small Claims, and Summary Evictions**

- 2 (1) For the filing of an application for default judgment --\$15.00;
- 3 (2) For the filing of a motion for summary judgment--\$15.00;
- 4 (3) For the filing of an amended complaint for summary eviction--\$25.00;
- 5 (4) For the filing of a renewal of judgment--\$25.00.

7 **Section 3 – Specialty Court Participation Fees**

- 8 (1) For missing a drug screen or testing positive on a drug screen--\$25.00;
- 9 (2) For missing a required appointment in a specialty court program--\$75.00;
- 10 (3) For performing and evaluating/assessing for eligibility for a specialty court program--
- 11 **\$100.00;**
- 12 (4) For missing a treatment facility's initial evaluation--\$150.00;
- 13 (5) For the veterans' treatment court program fee--\$600.00;
- 14 (6) For the drug court program fee--\$750.00;
- 15 (7) For the DUI serious offender program fee--\$800.00.

18 **November 10, 2022;** and


